(i) A Master Degree in the relevant field obtained after a full-time course of study of at least 02 academic years (or an equivalent part-time course of study) with a research component by way of thesis/dissertation or a Doctoral Degree or MD/MS & Board Certification by the postgraduate Institute of Medicine where or its equivalent.

<u>OR</u>

(ii) Such professional qualifications & experience as may be approved by the University Grants Commission upon the recommendation of the Higher Educational Institution concerned.

AND

- 3 At least six (6) years of experience in one or more of the followings:-
 - (i) Teaching at University Level
